


- **Project Limits:** FM 740 to Tubbs Road
- **Description:** Widen 2 lane asphalt to 4 lane divided concrete
- **Construction Start Date:** January 2016
- **Completion Time:** January 2018





Interchange

- **Project Limits:** Intersection IH 30 and FM 3549
- **Cost:** \$32.8 Million
- **Completion Date:** Fall 2018





Rehabilitation Project

- **Project Limits:**
SH 276 to SH 205
- **Description:** Remove and replace asphalt surface and improve shoulders; adding two left turn lanes along SH205 @ both FM 549 intersections
- **Bid Date:** March 2015





- **Project Limits:** IH 30 to north of SH 66
- **Description:** Widen existing 2-lane asphalt to 4-lane divided concrete
- **Est. Construction Cost:** \$9.9 Million
- **Funding:** Proposition 1
- **Bid Date:** August 2018



- **Project Limits:** SH205 to FM 549
- **Description:** Widen existing 2-lane to 4-lane divided (ultimate 6-lane)
- **Est. Construction Cost:** \$17 Million
- **Funding:** Proposition 1
- **Bid Date:** Fall 2017





- **Project Limits:** SH205 to SH66
- **Description:** Widen existing 2-lane facility to a 4-lane divided urban roadway
- **Est. Construction Cost:** \$46 Million
- **Bid Date:** March 2023
- No Time frame for construction





Interim Project

- Project Limits: John King Blvd to Hunt County Line
- Description: Rehab existing 2-lane facility, widen shoulders, add turn lanes at various intersections
- Construction Cost: \$15.8 Million
- Bid Date: March 2, 2016
- Complete: January 2019





- **Project Limits:** SH205 to Hunt County Line
- **Description:** Widen existing 2-lane facility to a 4-lane divided urban roadway
- **Construction Cost:** \$120.5 Million
- No timeframe at this time

Widening Project

- **Project Limits:** SH 276 to SH 205
- **Description:** Widen existing 2-lane rural facility to 4-lane urban roadway
- **Est. Construction Cost:** \$17.8 Million
- **Bid Date:** March 2020


- **Project Limits:**
SH 78 to US 80
- **Description:** Widen existing 2-lane rural facility to 4-lane divided with allowance for ultimate 6-lanes
- **Est. Construction Cost:**
\$200 Million
- **Bid Date:** December 2021

- **Project Limits:** Bass Pro to Hunt County Line
- **Description:**
 - Bass Pro to SH205: 8-lane (4 each direction)
3-lane (service roads)
 - SH205 to County Line: 6-lane (3 each direction)
2-lane (service roads)
- **Construction Cost:** \$698 Million
- **Bid Date:** December 2020/2021

Summit Ridge Dr

- **Project Limits:**
SH66 to FM 740
- **Description:** Reconstruct existing street pavement , replacement of water lines and wastewater lines and storm drainage improvements
- **Est. Construction Cost:**
\$7.5 Million
- **Bid Date:** No determined






E Boydston Ave



Throckmorton St

- **Project Limits:**
 - Boydston (Goliad to Clark)
 - Throckmorton (Boydston to Bourn)
- **Description:** Reconstruction of existing roadways, 5' concrete sidewalks, water line and wastewater line replacements, and storm sewer improvements
 - Boydston: Existing 36' wide asphalt/concrete roadway to 41' concrete roadway
 - Throckmorton: Existing 20' wide asphalt roadway to 29' concrete roadway
- **Cost:** \$4.0 Million
- **Bid Date:** Spring/Summer 2017






County Line Rd

- **Project Limits:**

- FM 3097 to Renee Dr.



- **Description:**

- Existing: 24' wide asphalt roadway
- Proposed:
 - FM 3097 to Eva Pl.: Proposed 37' wide concrete roadway
 - Eva Pl. to Russel Dr.: Proposed 29' wide concrete roadway
 - Russel Drive to Renee Dr.: Proposed 24' wide asphalt reclamation
 - 5' concrete sidewalks
 - Water line and wastewater line adjustments and relocations
 - Storm sewer improvements

- **Cost:** \$5.7 Million

- **Bid Date:** Winter 2017/2018
